#### **Amended Planning Application – Land off Vicarage Lane**

Members of the public raised the following objections:

- Removal of the existing ash tree. Work is continuing with the Woodland Trust to have this tree recognised as a 'veteran'.
- Lack of proven housing need.
- It was noted that the relevant planning documents for the amendments had not been easy to find online.

#### **WW1 Commemoration Beacon**

Cllr Gibb explained that owing to various health and safety concerns and logistical issues which required more time to resolve, it had been decided that this event at Windmill Hill would not now go ahead. There will still be events taking place in Harbury to mark this special occasion.

#### **1    17/02311/FUL (amended)**

Demolition of existing dwelling (No 4 Vicarage Lane) and erection of 10 residential dwellings with associated access, car parking, landscape and associated details

#### **Land at Vicarage Lane**

It was **RESOLVED** to object on the same grounds as previously and to reiterate those objections. It was agreed that Cllr Lockley would draft a formal response for circulation and approval by councillors which the clerk would then submit to SDC.

**2 Harbury Neighbourhood Development Plan**

A positive report had been received from the examiner who had recommended a few modifications. It was **RESOLVED** to approve the proposed amendments. This referendum version of the NDP will now be sent to SDC.

**3 Draft Strategic Housing Land Availability Assessment 2018 – Consultation**

Most sites in and around Harbury had been discounted. It was noted that public transport is less than hourly and therefore should be amber not green. No other material errors were identified. The clerk will respond to SDC accordingly.
